**RESOLUTION APPROVING THE TERMS OF THE CONTRACT WITH CIGNA
HEALTHCARE FOR STOP LOSS INSURANCE AND AUTHORIZING THE
WILLIAMSON COUNTY MAYOR TO EXECUTE THE CONTRACT**

- WHEREAS,** counties may provide group life, hospitalization, disability, and medical insurance for county employees, officials, certain retirees, spouses, and certain dependents in accordance with *Title 8, Chapter 27*; and
- WHEREAS,** the applicable statutes provide that a contract for insurance coverage shall be presented to the county legislative body for approval by majority vote; and
- WHEREAS,** the Purchasing and Insurance Committee voted unanimously to recommend the proposal submitted by Cigna Healthcare (“Cigna”) for Individual Stop Loss Insurance Coverage; and
- WHEREAS,** the contract with Cigna will be for twelve months beginning July 1, 2025, and will provide medical stop loss insurance coverage; and
- WHEREAS,** the Williamson County Board of Commissioners has determined that it is in the interest of the citizens of Williamson County to approve the contract and authorize the Williamson County Mayor to execute the contract submitted by Cigna:

NOW, THEREFORE, BE IT RESOLVED, that the Williamson County Board of Commissioners, meeting in regular session, this the 9th day of June, 2025, hereby approves the terms of the contract and authorizes the County Mayor to execute the contract and any amendments to the degree permissible by *Title 8, Chapter 27* with Cigna Healthcare and is directed to take all actions necessary to effectuate the stop loss policy as further described in the contract.
